Sub: - In the matter of Unauthorized Nidhi Companies under section 406 of the Companies Act, 2013

Sir,

With reference to the subject cited above and in continuation of this Directorate's earlier letter vide no. RD(West)/Nidhi Cos/202+0 dated 26-10-2020, 14-06-2021 & 16.06.2022, I am to enclose herewith the further list of Nidhi Companies along with their addresses whose NDH-4 (Declaration Nidhi Company) have been rejected by the Central Government and thus consequently they are barred from functioning as Nidhi Companies and also accepting money from its members or inviting general public to become its members.

Further, there are companies working as Nidhi or Mutual Benefit Society but have not filed an application NDH-4 for getting them declared as Nidhi Company as per Section 406 of the Companies Act, 2013 and Rules thereunder. It is, therefore, important to keep a close eye/watch on such companies and ensure that no Nidhi company operates without declaration by the Central Government especially those companies where NDH-4 filed by them have been rejected.
